Carl B. Holland, his heirs and assigns:

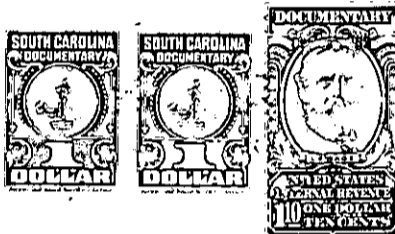
All that certain piece, parcel or lot of land lying and being on the Southeasterly side of Mayo Drive, near the City of Greenville, S. C., being shown as Lot No. 190 on the plat of Paramount Park recorded in the RMC Office for Greenville County, S. C. in Plat Book "W", page 57, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Mayo Drive at a point 101.2 feet Northeast of the Easterly intersection of Mayo Drive and Crosby Circle, said pin being the joint corner of Lots Nos. 155 and 190, and running thence along the joint line of said Lots S 33-02 E 80.2 feet to an iron pin in the center of a 10 foot strip reserved for utilities, said pin being also the joint corner of Lots Nos. 155, 156 and 190; thence along the center of said 10 foot strip S 89-21 E 90 feet to an iron pin, joint rear corner of Lots Nos. 189 and 190; thence along the joint line of said Lots N 30-54 W 120.4 feet to an iron pin on the Southeasterly side of Mayo Drive; thence along the Southeasterly side of Mayo Drive S 64-00 W 80 feet to the point of beginning.
