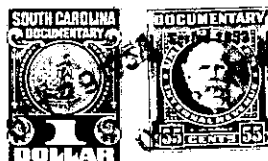
That I, Johnnie W. Mansel in the State aforesaid,

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, on the north side of Happy Avenue, being known and designated as lot No. 26 on plat of Rutherford Park made by Dalton & Neves, Engineers, September 30, 1946 recorded in the R. M. C. Office for Greenville County in plat book P at page 109 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Happy Avenue, the joint corner of lots Nos. 26 & 27, and running thence with the joint line of said lots N. 15-12 W. 148.1 feet to an iron pin corner of lot No. 10; thence with the rear line of said lot S. 72-30 W. 45 feet to an iron pin corner of lot No. 25; thence with the line of said lot S. 15-12 E. 146.1 feet to an iron pin on the north side of Happy Avenue; thence with the north side of said Avenue N. 74-48 E. 45 feet to the beginning corner.
