All that certain piece, parcel or tract of land in Bates Township, Greenville County, South Carolina, containing 1.0 acres more or less, lying to the North of South Carolina Highway No. 288, sometimes referred to as Pumpkintown Road, about two miles West from Marietta, and having according to a survey prepared by Piedmont Engineering Service, Greenville, S. C., October 1952, the following metes and bounds, to-wit:

BEGINNING at an iron pin lying Northeast of the center line of the present water pipe lines of the City of Greenville, approximately 1,000 feet in a Westerly direction from the point where said water lines cross S. C. Highway No. 288, and running thence S. 41-08 W. 190 feet to an iron pin; thence N. 48-52 W. 230 feet to an iron pin; thence N. 41-08 E. 190 feet to an iron pin; thence S. 48-52 E. 230 feet to the beginning corner.

Being a portion of the same tract of land conveyed to the Grantors herein by deed of E. E. Stone and Harriet M. Stone. Individually and as Trustees, dated December 10, 1951 and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 447, at page 285.

Together with a right-of-way and easement for the construction and maintenance of a roadway leading from S. C. Highway No. 288 to the tract of land hereinabove described, said right-of-way to be 50 feet in width and located approximately as shown on the plat attached to this deed which is incorporated in and made a part hereof.
