

thirty days after plans and specifications have been submitted to it, or in any event, if no suit to enjoin the construction has been commenced prior to the completion thereof, such approval will not be required and this Covenant shall be deemed to have been fully complied with.

3: No dwelling costing less than \$7000.00 shall be permitted on any residential lot, This cost price is based upon the cost levels prevailing on the date these Covenants are recorded, it being the intention and purpose of this Covenant to assure that all dwellings shall be of a quality or workmanship and materials substantially the same or better than that which can be produced on the date these Covenants are recorded at the minimum cost stated therein for the minimum permitted dwelling site. The ground floor area of the main structure, exclusive of one story open porches and garages, shall be not less than 750 square feet for a one story building, nor less than 600 square feet for a dwelling of more than one story.

4: No building shall be located on any residential lot near than 35 feet to the front lot line, or nearer than 35 feet to any side street line. No building, except a detached garage or other outbuilding located 75 feet more or less, from the front lot line, shall be located nearer than 5 feet to any side lot line.

5: No residential lot shall be subdivided. No residential structure shall be erected or placed on any residential lot which has an area of less than 10,000 square feet or a width of less than 70 feet at the front building set back line.

6: No noxious or offending trade or activity shall be carried on upon any lot, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.

8: After the installation of water lines, all sewerage disposal shall be by septic tank meeting the approval of the State Board of Health or by Municipal Sewerage System.

9: On any residential lot, no structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used at any time as a residence, either temporarily or permanently.
