All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Twenty-four (24) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

BEGINNING at a point on Waston Street joint front corner of Lots 23 and 24 and running thence along Waston Street S. 43-0 W. 60 feet to corner of Lot No. 25; thence along the line of Lot No. 25 N. 47-0 W. 122.7 feet to point on rear line of Lot No. 49; thence along the rear line of Lots 49 and 50 N. 43-C E. 60 feet to corner of Lot No. 23; thence along the line of Lot No. 23 S. 47-0 E. 122.7 feet to the beginning corner.

The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine, by deed dated March 10, 1951, and recorded in the R.M.C. Office for Greenville County in Deed Book 430, page 372.
