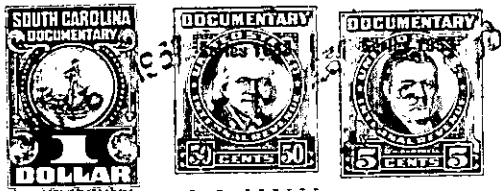

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said James W. Webb, W. A. Galloway  
and C. L. Trammell as Trustees of Church of God of Conestee, S. C.

all that piece, parcel or lot of land in Butler Township.

County, State of South Carolina, lying and being on the Southwestern corner of  
the intersection of Conestee Road and Standing Springs Road and being  
known and designated as Lot #1 of Property of E. L. Craigo as shown  
on plat thereof by W. J. Riddle, Surveyor, dated March, 1948 and  
having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southwestern corner of the inter-  
section of Conestee Road and Standing Springs Road and running thence  
along the Western side of said Standing Springs Road, S. 62-39 E. 149.4  
feet to an iron pin; thence still along Standing Springs Road, S. 56-  
28 E. 66 feet to an iron pin on the North side of a 10-foot alley;  
thence along the North side of said alley, S. 54-28 W. 235.6 feet to an  
iron pin at the rear corner of Lot #4; thence along the line of Lot #4,  
N. 23-29 W. 220.7 feet to a point on the South side of Conestee Road;  
thence along the South side of Conestee Road, N. 66-31 E. 100 feet to  
the beginning corner.

The above described property is the same conveyed to me by E. L. Craigo  
by deed dated May 14, 1948 recorded in the R.M.C. Office for Greenville  
County in Deed Book 346, page 355.

Trustees of Church of God of Conestee, S. C., their Successors and  
Assigns forever, in trust however for the following uses and purposes,  
to-wit:

The said Local Board of Trustees shall hold title to, manage and  
control the said real estate for the general use and benefit of the  
Church of God, having its general headquarters in Cleveland, Tennessee,  
and for the particular use and benefit of the local congregation  
of the said Church at Conestee, South Carolina.
