Beginning at an iron pin on or near the south side of Reids School Road, common corners of lots 9 and 10 and running thence S. 87-30 W. 262.5 feet to the rear corners of lots 9 & 10; thence S. 2-30 E. 100 feet to an iron pin common corners of lots 8 & 9; thence N. 87-30 E. 298 feet to iron pin on or near the south side of Reids School Road, common corners of lots 8 & 9; thence with said road N. 22-07 W. 105.9 feet to the point of beginning.

Beginning at an iron pin on the west side of Reid School Road common corners of lots Nos. 9 & 10, and running thence S. 87-30 W. 262.5 feet to an iron pin, common rear corners of lots 9 and 10; thence N. 2-30 W. 100 feet to an iron pin, common corner of lots 10 & 11; thence N. 87-30 E. 226 feet to an iron pin on the west side of the Reid School Road; thence with the west side of said road S. 22-34 E. 106.4 feet to a point and place of the beginning.
