Allen Miles -- his heirs and assigns all that piece, parcel or Lot of Land in Gantt Township County of Greenville, State of South Carolina and having the following metes and bounds. . Beginning at an Iron pin on Smith Street at the South Corner of the Blasingame Lot and running with Smith Street 315 feet to an Iron pin at the North corner of the Clyde Baker Lot thence N 56-35 W 416.7 Feet to an Iron pin on the Zet Smith property line thence S. 33-25 W along said line 315 feet to an Iron pin thence S 56-35 E 417 feet to the point of beginning.

This deed is made to correct the description in a certain warranty deed made by the parties of the first part to the party of the second part dated 8/11/47 and recorded in the R. M. C. office for Greenville County at 328-11 in that the party of the second part herein agreed by separate instrument recorded, that the metes and bounds are to conform to a plat of the Zet Smith property drawn by J.
