to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Moses Dillard -- his heirs and assigns all that piece, parcel or lot of land in Gantt Township, County of Greenville, State of South Carolina and having the following metes and bounds. Beginning at an iron pin at the joint rear corner of the William Blassingame and Leo Sherman Lots and running thence N. 34-00 E. 406' to an iron pin on the Zet Smith line at the rear corner of the Louise Jackson Lot; thence S. 61-06 W. 451' to an iron pin; thence S. 54-02 E. 208' to the point of beginning.

This deed is made to correct the description in a certain warranty deed made by the parties of the first part of the party of the second part dated 7-28-48 and recorded in the R. M. C. Office for Greenville County at 361-187 in that the party of the second part herein agreed by separate instrument recorded, that the metes and bounds are to conform to a plat of the Zet Smith property drawn by J. Mae Richardson R. L. S. April 1951 and recorded in the R. M. C. Office for Greenville County.

Said plat being recorded in Plat Book F F, at Pages 34 and 35.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
