Know All Men by These Presents:

That I, Walter W. Goldsmith in the State aforesaid,
in consideration of the sum of FIVE HUNDRED FORTY FIVE AND NO/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ella Mae Hill, her heirs and assigns, forever:

ALL that piece, parcel or lot of land located outside city limits of Greenville near White Horse Road and Easley Highway 29, in a subdivision known as Dolando hills, according to plat made July 1950 by Piedmont Engineering Company and recorded in RMC Office for Greenville County in plat Book "AA" at page 71, said lot being more particularly described as follows:

BEGINNING at an iron pin on NW/s of Morrell Drive, joint corners of lots 20 and 21 and running thence N. 19-06 E. 70' along Morrell Drive to an iron pin, joint corners of lots 20 and 19; thence N. 70-54 W. 138.5' to an iron pin; thence S. 19-06 W. 70' to an iron pin; thence S. 70-54 E. 138.5' to an iron pin on Morrell Drive point of beginning, being known and designated as lot 20 of Block C.

Restrictions:

1. Said lands shall not be sold, rented or otherwise disposed of to any person of African descent.
2. No residence shall be erected at a cost of less than \$3000; nor nearer than 25' to the front line; nor shall any residence be erected on any lot unless said lot have 50' frontage or more.
3. No outside toilets are permitted and sewage must be disposed by approved septic tanks.

Grantee herein to pay taxes for the year 1953

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
