Price, her heirs and assigns, all of our undivided interest in the following described property, all that piece, parcel or lot of land lying and being in Greenville County, State of South Carolina having the following description:

BEGINNING on a stake in the road on the outside line, the Clelia A. Poole corner, and running with said road N 32.00 W 409 feet to a stake in the road; thence S 68.30 W crossing the branch and the Gap Creek Road 1050 feet to the outside line at the top of the mountain; thence with the outside line S 47.00 E 850 feet to a stake; thence N 22.30 E 528 feet to a stake on the south side of the old Gap Creek Road; thence N 68.30 E 390 feet to a stake in the road, the beginning corner. Containing 11.25 acres more or less.

The above described land is better shown by a blue print made by W. P. Morrow, Land Surveyor, and is known as lot No. 1 of the subdivision of the estate of W. W. Poole.
