in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Joe King Tate, his heirs and assigns:

All that piece, parcel or lot of land in Bates Township, Greenville County, State

of South Carolina, lying and being situate on the Northwesterly side of U. S. Highway No. 25 (Formerly known as Duncombe Road), near Travelers Rest, S. C., being known and designated as Lot No. 4, according to plat of the property of M. W. Tate estate, prepared by J. C. Hill, Registered Surveyor, dated March 7, 1953, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of U. S. Highway No. 25 (Formerly Duncombe Road), at joint front corner of Lots Nos. 4 and 5; thence along the joint line of those lots, N. 59-15 W. 316.1 feet to an iron pin; thence continuing N. 42-00 W. 209 feet to iron pin at joint rear corner of Lots Nos. 4 and 5; thence S. 31-00 W. 131.35 feet to an iron pin at joint rear corner of Lots Nos. 3 and 4; thence along the joint line of those lots, S. 46-05 E. 460.5 feet to an iron pin at joint front corner of Lots Nos. 3 and 4 on the Northwesterly side of U. S. Highway No. 25; thence along said highway, N. 51-30 E. 186.25 feet to an iron pin at joint front corner of Lots Nos. 4 and 5; the point of beginning.

The herein named grantee is to pay the 1953 taxes on the above described property.
