Know All Men by These Presents:

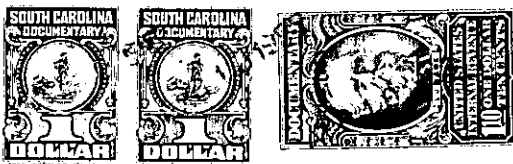

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Phillip R. Williams, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 32, Hudson Acres, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Y, at page 39, and having, according to said plat, the following notes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Greenwood Avenue, joint front corner of Lots Nos. 32 and 33 and running thence N. 84 E. 253.6 feet to an iron pin; thence S. 4-45 E. 124 feet to an iron pin joint rear corner of Lots Nos. 31 and 32; thence S. 66-15 W. 262.4 feet to an iron pin on the Easterly side of Greenwood Avenue; thence along the Easterly side of Greenwood Avenue, N. 14-20 W. 50 feet to a point; thence continuing along the Easterly side of Greenwood Avenue, N. 6-0 W. 150 feet to an iron pin, the point of beginning.
