


Goldsmith, herein called grantee, all that lot in the city and county of Greenville, S. C., which is located on the eastern side of River Street and is shown as Lot 38 on plat of Nicholtown Heights No. 2 made by W. J. Riddle in April 1941, and recorded in plat Book M, Page 5, and is also shown on plat of property of Sarah S. Goldsmith by Piedmont Engineering Co. dated March 1953, .from which plat the following description is taken:

BEGINNING at a point on the eastern side of River Street which point is 329.2 from the northeastern intersection of River St. and Hall Street and is the joint front corner between Lots 37 and 38, and running thence the joint line between these lots N. 56-0 E. 120' to the joint rear corner with these lots and Lots 25 and 26; thence the joint rear line between Lots 26 and 38, S. 34-0 E. 40' to the joint rear corner of Lots 26, 27, 38 and 39; thence the joint line between Lots 28 and 30' S. 56.0 W. 120' to the joint rear corner of Lots 26, 27, 38 and 39; thence the joint line between Lots 28 and 30' S. 56.0 W. 120' to the joint line between Lots 28 and 30 Lots 38 and 39, S. 56-0 W. 120' to their joint front corner on the eastern side of River Street; thence this edge of said street N. 34-0 W. 40' to the beginning corner.
