That I, W. S. Huff, in the State aforesaid, in consideration of the sum of Five Hundred Seventy Five & No/100 (\$575.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Paul L. Scarborough, his heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 23, Block A, Woodland Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book J, at pages 70 and 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Grove Road, joint front corner of Lots Nos. 22 and 23, and running thence N. 62-36 W. 190.2 feet to an iron pin; thence N. 42-0 W. 107 feet to an iron pin, joint rear corner of Lots Nos. 22 and 23; thence N. 48-0 E. 15 feet to a point in the rear line of Lot No. 23; thence S. 42-0 E. 107 feet, more or less, to a point; thence S. 62-36 E. 190.2 feet, more or less, to a point in the front line of Lot No. 23 on the West side of Grove Road; thence along the West side of Grove Road, S. 27-24 W. 15 feet to an iron pin, the point of beginning.

Being a fifteen (15) foot strip adjoining the property of Paul L. Scarborough, known as Lot No. 22, Woodland Subdivision.

BEING a portion of the property conveyed to the grantor herein by Piedmont Corporation, by deed dated February 5, 1940, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deeds Vol. 218, at page 337.

The grantee herein is to pay the 1953 taxes on the above described property.
