All that piece, parcel or lot of land, situate, lying and being in the City of Greenville; County of Greenville, State of South Carolina, being known and designated as Lot 105, Plat of Pleasant Valley, as per plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book P, at Page 114, and revised and recorded in the Plat Book EE, at Page 5, and having according to said plats, the following metes and bounds, to-wit:
