

BEGINNING at an iron pin on the South side of Lindell Street at the joint front corner of Lots 50 and 51, said iron pin being 60.7 feet westerly from the southwest corner of the intersection of Lindell Street and Woodlawn Avenue and running thence along line of Lot 50 S. 16-05 E. 145 feet to an iron pin; thence S. 74-26 W. 100 feet to the joint rear corner of Lots 48 and 49; thence along the line of Lot 49, N. 16-05 W. 145 feet to an iron pin on the South side of Lindell Street; thence along the South side of Lindell Street N. 74-26 E. 100 feet to the beginning corner.
