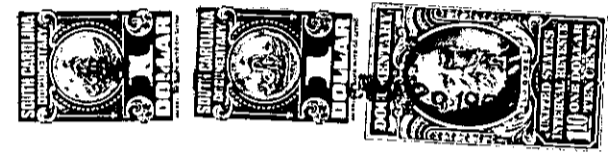
Know All Men by These Presents:

That We, W. R. Anderson and Jessie Belle Anderson, in the State aforesaid,
in consideration of the sum of Six Hundred Fifty (\$650.00) and No/100 - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said, Claude B. Cannon, and his heirs and assigns forever, All of that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying on the Northern side of Virginia Avenue, in the City of Greer, and being known and designated as Lot No. 29 on Plat of Development No.2, Victor-Monaghan Co., Division of J. P. Stevens & Co., Inc., Greer Plant, prepared by Dalton & Neves, Engineers, April 1947, and recorded in R.M.C. Office for Greenville County in Plat Book P. at page 119, and having according to said plat, the following metes and bounds;

Beginning at a point on the northern side of Virginia Avenue, at the joint front corner of Lots 29 and 30, and runs thence along the common line of said lots N.35-21 E. 170 feet to a point on the edge of a 10-foot alley; thence along the southern side of said alley S.54-39 E. 105 feet to a point, the joint rear corner of lots 28 and 29; thence along the common line of said lots S.35-21 W. 170 feet to a point on the northern side of Virginia Avenue; thence along Virginia Avenue N.54-39W. 105 feet to the beginning corner, and being all of the same lot of land conveyed to us by James B. Haney and Dorothy S. Haney by deed dated the 30th day of August, 1951 and recorded in the Office of R.M.C. for Greenville County in Volume 441 at page 199.

The property herein conveyed is subject to the restrictive covenants which are recorded in the R.M.C. Office for Greenville County, in Deed Volume 310 at page 417, reference to which is hereby made.

And the grantor(s) do hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
