
## STATE OF SOUTH CAROLINA





Know All Men by These Presents:

in the State aforesaid, That I, E. C. Greer, in consideration of the sum of Ten Thousand Five Hundred and no/100 (\$10,500.00) DOLLARS,

to the grantor(x) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ellie Louise Cason,

All that certain piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, containing 71 acres, more or less, having adjoining landowners as of April 17, 1908, and having the following metes and bounds, according to a plat thereof prepared by W. A. Adams, surveyor, bearing date of February 25, 1908:

Beginning at a stone on the south bank of Brushy Creek of Enoree River, and running thence along line of land of the Pelham Mills S. 33 1/2 W. 33.75 chains to a stone 3XOM; thence N. 57 W. 11.50 chains to a stone in road leading from E. F. Trapier's to the Sudduth house; thence N. 25 1/4 E. 5.45 chains to a stone 3X; thence along line of B. F. Trapier's land M. 65 1/2 W. 14.27 chains to a red oak; thence 4. 34 1/2 E. 19.76 chains along line of allen Robinson's land to a stone on Brushy Creek; thence down said creek following the meanders thereof as the line, to the beginning corner.

LESS, however, a portion of the aforestid tract deeded by the grantor to K. J. Satterfield by deed dated March 31, 1947, and recorded in the R. M. C. office for Greenville County, the said portion containing 20 acres, more or less, and having the following metes and bounds, to-wit:

Beginning on a Black Oak, joint corner of the lands of Ben Hamby, Grady Yeargin, Carrol Smith and runs thence with the Carrol Smith land S. 67-15 E. 935 feet to an iron pin on the west side of the road, thence a new line N. 3-25 E. 374 feet to an iron pin by a light post; thence N. 13-00 E. 1252 feet to a stake on Brushy Creek; thence up the creek as the line S. 71-45 W. 218 feet to a bend; thence S. 73-45 W. 125 feet to a point in the creek, and joint corner of the Ben Harby tract; thence with the Hamby line S. 36-15 W. 1403 feet to the beginning corner.
