All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as the greater portion of Lot No. 4 and a small portion of Lot No. 5 of the property of J. H. Mauldin according to a plat thereof prepared by C. C. Jones, C. E., September, 1952 and recorded in the R. M.
