A. D. Attaway, his heirs and assigns,

ALL that certain piece, parcel or lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots No. 64 and 65 on Brewster Drive according to plat of Pine Brook Development, made by W. N. Willis, Engineer, March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 149, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Western side of Brewster Drive, joint corner of Lots No. 6 and 65, thence S. 51-22 W. 150 feet to an iron pin in rear line of Lot No. 5; thence N. 33-31 W. 168.3 feet to an iron pin, joint of Lots 11, 13, 62 and 64; thence N. 56-29 E. 150 feet to an iron pin on Western side of Brewster Drive; thence along Brewster Drive, S. 33-31 E. 155 feet to an iron pin, point of beginning.
