J. D. Hamrick and Irma K. Hamrick, their Heirs and Assigns forever,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on Berkley Avenue between Darlington Avenue and the Franklin Road, in the Sans Souci Section of Greenville County, about three miles north of the City of Greenville, and being shown as a portion of Lot No. 20 on a revised plat of Lots Nos. 19 and 20, made by C. O. Riddle, Surveyor, July 13, 1953, and the property of Ruth H. and James D. Ashmore; said plat being a revised plat of the plat of Ethel Y. Perry Est., as recorded in R.M.C. Office for Greenville County in Plat Book "R", page 127, said revised plat to be recorded, and said lot having, according to said revised plat, the following metes and bounds:

BEGINNING at an iron pin on the southern edge of a five (5) foot sidewalk running along Berkley Avenue, said pin being the former joint front corner of Lots Nos. 20 and 21; thence running with the line of Lot No. 21, S. 9-08 W. 134.4 feet to an iron pin, former joint rear corner of Lots Nos. 20 and 21; thence along the rear line of Lot No. 28, S. 80- 03 E. 20 feet to a pin; thence through Lot No. 20, and being the new western line of Lot No. 20, N. 9-08 E. 134.7 feet to a pin on the southern edge of the five (5) foot sidewalk running along Berkley Avenue; thence along the southern edge of said sidewalk, N. 80-52 W. 20 feet to an iron pin, the point of beginning.
