All that piece, parcel or lot of land with the improvements thereon situate, lying and being in Monaghan Mills Village, Greenville County, South Carolina, and being more particularly described as Lot No. 112, Section 3..., as shown on a plat entitled Sub-V1SEC March, 1953 office for Greenville County in Plat Book 1 at Page xx/1/2 xinclosix. According to said plat, the within described lot is also known as No. 10 Smythe Street CAMPROCK and fronts thereon

The grantor and its predecessors in title have granted unto Parker Water and Sewer Sub-District, Commissioners of Public Works of the City of Green-Company and Southern Public Utilities Company, and Southern Public Utilities Company, and Southern Bell Telephone and Telegraph Company, to one or more of them and/or to others all water and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sewer lines), valves, fittings, protection, electric light and power distribution, and sewerage systems of the village known as Monaghan Mills Village in which the above described lot is tion, and operation (including meter reading) of the lines and systems aforesaid and of certain other water, sewer, electric, telephone and street trolley in Monaghan Mills Village and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the R. M. C.

There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described and this conveyance is made subject to the rights of way and easements above mentioned insofar as they may affect said lot.

This conveyance is made subject to the following restrictions:

(1) That no livestock, except fowl, may be kept, stabled or penned thereon or brought to the premises. Or brought to the premises.

(2) That no mercantile establishment shall be erected, operated or maintained on the lot above described.

(3) That only one residence shall be erected or maintained on any one lot.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.
