Know All Men by These Presents:

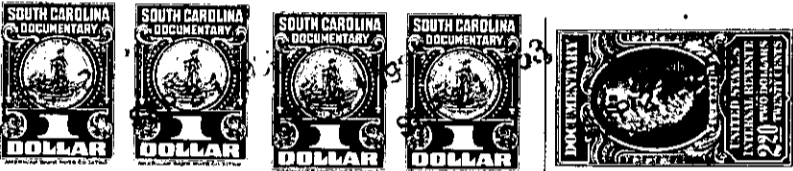

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mrs. Cleo G. Saad and Mr. Sauzy S. Zahka, their heirs and assigns forever,

ALL that piece, parcel or tract of land in School District 4-F, Greenville, South Carolina and containing 3.06 acres, more or less, according to a survey made by C. C. Jones, Engr. on April 1952 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on Augusta Road at the joint front corner of property of Grantor and Donaldson Air Force Base and running thence North 80-45 East 38.2 feet to a point; running thence South 61-25 East 233 feet to an iron pin; thence continuing along the joint line of property of Grantor and Donaldson Air Force Base, South 53-55 East 127.2 feet; running thence South 50-20 East 289.7 feet to an iron pin; running thence South 63-38 West 200 feet to an iron pin; running thence North 59-59 West 53 feet to an iron pin; running thence North 59-59 West 98.3 feet to an iron pin; running thence South 78-06 West 193.2 feet to an iron pin on Augusta Road; thence along Augusta Road, North 9-15 West 423 feet to an iron pin, the beginning corner.
