

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Johnnie F. Bell and Mary C. Bell, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, on the north side of Alameda Street (formerly known as South Street), being known and designated as Lot No. 13 of the property of W. N. Miller and E. E. Stone according to a plat thereof prepared by Will D. Neves, March 12, 1914 and recorded in the R. M. C. office for Greenville County in Plat Book C, at page 235, and having, according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the northwestern side of South Street (now known as Alameda Street), joint front corner of Lots Nos. 11 and 13, and running thence along the joint line of said lots, N. 0-50 W. 89 feet to an iron pin on the southern side of an 8-foot alley; thence along the southern side of said 8-foot alley, S. 76-30 W. 34.7 feet to an iron pin at the rear corner of Lot No. 15; thence along the line of that lot, S. 1-30 E. 95 feet to an iron pin on the northwestern side of South Street (now known as Alameda Street); thence along the northwestern side of South Street (now known as Alameda Street), N. 66-40 E. 35.6 feet to the beginning corner; being the same conveyed to me by A. M. Stone by deed not yet recorded.

The above described lot is shown on the Township Block Book at Sheet 201, Block 9, Lot No. 19, and the grantees are to pay taxes for the year 1953, said taxes having been prorated as of this date.
