

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Arch Eborn Cutting, his heirs and assigns, forever.

All that certain piece, parcel, or lot of land with the buildings and improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, and now within the corporate limits of the City of Greenville, on the north side of Dellwood Drive, and being known and designated as Lot No. 5 of a subdivision of the property of the Central Development Corporation as shown on plat thereof made by Dalton & Neves, Engineers and recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Pages 22 and 23, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of Dellwood Drive at the corner of . Lot No. 4, and running thence along the line of that lot, N. 12-06 E. 172 feet to an iron pin on the south side of an unnamed street; thence along the south side of said unnamed street, N. 77-54 W. 50.1 feet to an iron pin on the south side of said street; thence following the curvature of the intersection of said street with Holmes Drive, the chord of which is S. 60-11 W., 37.2 feet to an iron pin on the east side of Holmes Drive; thence along the east side of Holmes Drive, S. 18-16 W. 52 feet to an iron pin; thence continuing along the east side of said Holmes Drive, S. 30-16 W. 77.8 feet to an iron pin; thence following the curvature of the intersection of said Holmes Drive with Dellwood Drive, the chord of which is S. 19-33 E., 20.1 feet to an iron pin on the north side of Dellwood Drive; thence along the north side of Dellwood Drive, S. 75-22 E. 97.4 feet to the beginning corner. This lot is conveyed subject to the restrictions as recorded in the R. M. C. Office for Greenville County.
