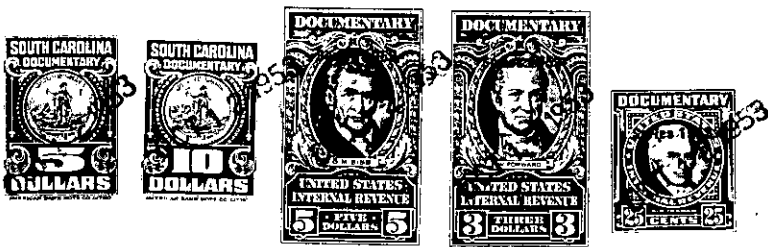
Know All Men by These Presents:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the western side of Franklin Road, near the City of Greenville, being shown as Lot No. 1 on plat of property of J. P. Rosamond, recorded in Plat Book H, at page 186 and described as follows:

Beginning at a stake on the western side of Franklin Road, corner of property now or formerly owned by B. E.
