KNOW ALL MEN BY THESE PRESENTS. That I, Ben F. Perry, of the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars (\$10.00.) and other valuable considerations, to me in hand paid at and before the sealing of these presents by W. R. Harrison, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. R. Harrison,

all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Mt. Pleasant Avenue between the New Buncombe Road and the Tindal Road, in Sans Souci Heights, a Sub-Division situate on the New Buncombe Road about four miles north of the City of Greenville, said lot having the following lines, courses and distances:-

Beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Mt. Pleasant Avenue, said pin being the joint front corner of lots numbed thirty-one (31) and thirty-two (32); thence along the northern edge of said sidewalk, S. 50-50 W., seventy-five (75) feet to an iron pin, joint front corner of lots thirty (30) and thirty-one (31); thence along the eastern line of lot thirty (30), N. 32-14 W., one hundred and sixty-eight and five tenths (168.5) feet, to an iron pin, joint rear corner of lots thirty (30) and thirty-one (31); thence along the rear line of lot twenty-seven (27), N. 62-50 E., sixty-six and four tenths (66.4) feet, to an iron pin, joint rear corner of lots thirty-one (31) and thirty-two (32); thence along the western line of lot thirty-two (32), S. 35-24 E., one hundred and fifty-four (154) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbed thirty-one (31) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Book "A" at page 155, which Plat is hereby referred to and made a part hereof.
