Know All Men by These Presents:

That I, M. W. Fore in the State aforesaid, in consideration of the sum of One & 00/100 (\$1.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

RUTH SEAY, her heirs and assigns, forever:

ALL that piece, parcel or lot of land near the City of Greenville, Greenville County, State of South Carolina, being known and designated as Lot No. 20 of Section No. 1 of a subdivision known as Caroline Court, as shown by a plat thereof, dated September, 1953, recorded in the R. M. C. Office for Greenville County in Plat Book "EE", Page 45, made by Dalton & Neves, Engineers, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of Manhattan Boulevard and Marlana Avenue at joint front corners of Lots No. 20 and 21 and running thence along the line of said Lot No. 21, N. 76-43 W. 182.8 feet to iron pin at back corner of Lot No. 13; thence along the rear lines of Lots No. 13 and 14, N. 25-15 E. 140 feet to iron pin on Manhattan Boulevard; thence with the said Manhattan Boulevard, S. 64-45 E. 39.3 feet to iron pin; thence still with the said Manhattan Boulevard, S. 46-49 E. 90 feet to an iron pin; thence still with the said Manhattan Boulevard and Marlana Avenue, S. 10-41 E. 91.7 feet to iron pin at point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence or business costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars, shall be erected on said lot, and no residence or building shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence or business shall be built on any lot unless said lot has fifty (50) feet, or more, frontage. No business building shall be erected on any lot other than lots fronting on U. S. Highway No. 29.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
