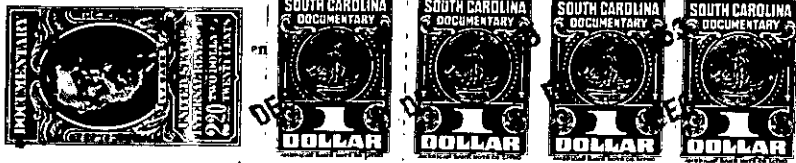

Know All Men by These Presents:

That I, T. D. Williams in the State aforesaid,  
in consideration of the sum of Sixteen Hundred Ten & no/100 - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. L. Henderson his Heirs and Assigns forever:

All that piece, parcel or tract of land lying, being and situate in the County and State aforesaid, Fairview Township, about 2.5 miles Southwest of the Town of Fountain Inn, S. C., containing twenty-five (25) acres, more or less, with the following metes and bounds, to-wit: Beginning an iron pin in the center of a road, about 100 yards from the public road that leads from Fountain Inn to Beulah Church, thence with the center of said road N. 58 W. 264 feet to an iron pin, joint corner with lot of the Grantee herein on said road; thence with joint line of lot of the Grantee in a Northeasterly direction 180 feet to the center of an eight inch bored well; thence from said well in a Northwesterly direction 306 feet to an iron pin; thence in a Southwesterly direction 180 feet to an iron pin, joint corner with lot of the Grantee; thence N. 18 W. 1034 feet to an iron pin on line of J. D. McDowell; thence with joint line of the land of the said J. D. McDowell N. 47-30 E. 850 feet to McDowell corner; thence S. 17-37 E. 1716 feet to a stone 3 X 0M; thence with line of McGee S. 53-55 W. 471 feet to an iron pin in center of road, the point of beginning, and bounded by lot of the Grantee, W. G. Abercrombie, J. D. McDowell, M. O. McGee and others.
