to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Z. V. Christy, his heirs and assigns:

All those two certain lots, pieces or parcels of land situate, lying and being in the County of Greenville, State of South Carolina, a short distance west of the City of Greenville, known and designated as Lots numbered ten (10) and twelve (12) of "Sunnyslope," according to a plat thereof made by R. E. Dalton in May, 1919, and recorded in office of Register of Meane Conveyances for said County in Plat Book "F", at page 86, and having, according to said plat, the following metes and bounds, collectively, to wit:

BEGINNING at a stake on the west side of Zarline Street, two hundred and two (202) feet southward from Fortner Street, on the south-east corner of Lot No. 8, and running thence with line of that lot N. 80-12 W. one hundred and fifty (150) feet to a stake on joint corner of Lots Nos. 7, 8, 9 and 10; thence S. 9-48 W. one Hundred and Three (103) feet to a stake on joint corner of Lots Nos. 11, 12, 13 and 14; thence S. 80-12 E. one hundred and fifty (150) feet along line of Lot No. 14 to a stake on the west side of Zarline Street; thence along said street N. 9-48 E. one hundred and three (103) feet to the beginning corner; said lots being in Block "B", these being parts of the lands conveyed to grantor's deceased mother, Vera Christy by deed dated November 14, 1936, and recorded in said office on November 14, 1936 in Plat Book "K", at Page 394.

This property was obtained by the grantor by the death of her mother Vera Christy, who died intestate.
