C. to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Earl D. Carter, his heirs and assigns forever.

All that piece, parcel, or lot of land, with the improvements thereon, situate, lying and being near the City of Greenville, S. C. and being more particularly described as lot 104, Section 1, as shown on a plat entitled "Subdivision of Village Houses, F. W. Poe Mfg. Co., Greenville, S.C.", made by Dalton and Neves, July 1950, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book Y, at page 26-31 inclusive. According to said plat, the within described lot is also known as No. 23 Third Avenue, and fronts thereon 65 feet.

This being the same property conveyed to the grantor by the F. W. Poe Mfg. Co., deed recorded in Book of Deeds, Vol. 420 at page 157 on October 2, 1950.

This conveyance is made subject to the Easement, Right of Way and restriction contained in the aforementioned deed.
