

BEGINNING at an iron pin on the Fast side of Virginia Avenue, at corner of lot 28, and running thence along the Fast side of Virginia Avenue, N. 15-10 W. 50 feet to iron pin, at corner of lot 30; thence with line of lot 30, N. 74-30 E. 130 feet to iron pin in line of property now or formerly of J.
