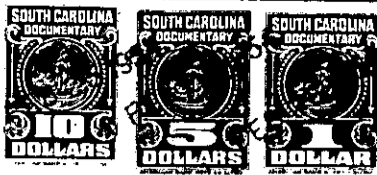

Know All Men by These Presents:

That I, L. A. MOSELEY

in consideration of the sum of Nine Thousand, Two Hundred Fifty and No/100 - - - - DOLLARS, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RAY L. CARR, HIS HEIRS AND ASSIGNS, FOREVER:

All that lot of land with the buildings and improvements thereon, situate on the northwest side of North Estate Drive, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 43 on plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Page 189, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of North Estate Drive, at joint front corner of Lots 42 and 43 and running thence with the line of Lot 42, N. 44-10 W. 165.3 feet to an iron pin; thence N. 52-30 E. 110 feet to an iron pin; thence with the line of Lot 44, S. 25-15 E. 169.7 feet to an iron pin on the northwest side of North Estate Drive; thence with the curve of North Estate Drive, (the chord being S. 53-50 W. 55 feet to the beginning corner.

The above described lot is one of the lots conveyed to the grantor and Walter L. Miller, Jr., by deed of Crestwood, Inc., dated May 24, 1952, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 468, at Page 536, and thereafter Walter L. Miller, Jr. conveyed his interest in the above lot to L. A. Moseley by deed dated January 19, 1953, recorded in said R.M.C. Office in Deed Book 470, at Page 395.

For restrictions applicable to Crestwood, Inc., see instrument on file in the Office of the R.M.C. in Deed Book 380, at Page 375.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

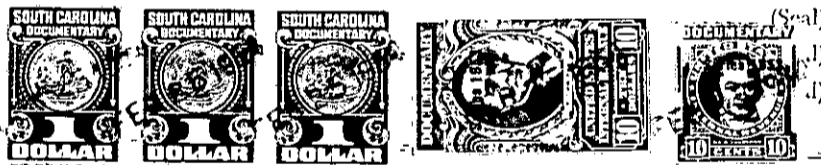
