G. Peterkin; thence with the line of the Peterkin property, N. 53-38 W., 462.3 feet to an iron pin in center of said 30-foot road; thence with the center of said road, S. 32-05 W., 416 feet; thence continuing with said road, S. 35-30 W., 205 feet; thence continuing with said road, S. 37-35 W., 100 feet to an iron pin in bend of said road; thence continuing with said road; thence continuing with said road, S. 67-35 W., 236 feet to an iron pin; thence continuing with said road, S. 46-45 W., 346 feet to the beginning sorrier.
