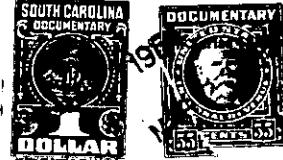

All that piece, parcel or lot of land in the State and County aforesaid and more particularly described as Lot No. 29 of Caroline Court, Section 1, as shown by plat recorded in the RMC Office for Greenville County in Plat Book EE at page 44, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin at the Southern side of Marlana Avenue at the joint front corner of lot Nos. 29 and 30 and running thence with the joint line of said Lots S. 25-15 W. 246 feet to an iron pin; thence N. 64-38 W. 100 feet to an iron pin, joint rear corner of lot Nos. 28 and 29; thence with the joint line of said lots N. 25-15 E. 245.8 feet to an iron pin on the Southern side of Marlana Avenue; thence with Marlana Avenue S. 64-45 E. 100 feet to the point of beginning.
