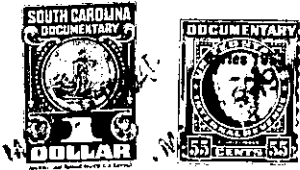

All that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as lot No. 251, Section 2, of Caroline Court recorded in the RMC Office for Greenville County in Plat Book GG, at page 21 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Marlana Avenue at the joint front corner of lot Nos. 250 and 251 and running thence with the joint line of said lots S. 25-15 W. 250.1 feet to an iron pin; thence N. 64-38 W. 100 feet to an iron pin; thence N. 64-38 W. 100 feet to an iron pin, joint rear corner of lot Nos. 251 and 252; thence with the joint line of said lots N. 25-15 E. 249.9 feet to an iron pin on the Southern side of Marlana Avenue; thence with Marlana Avenue S. 64-45 E. 100 feet to the beginning corner.
