Norman M. Cary, his heirs and assigns forever:

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 31 of Sherwood Forest, according to plat of Sherwood Forest recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book GG, pages 2-3, and having, according to a more recent plat of Property of Norman M. Cary, prepared by Dalton & Neves, Engineers, in May, 1954, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Scarlett Street at the joint front corner of Lots Nos. 30 and 31, which iron pin is approximately 281.56 feet from the intersection of Scarlett Street and Legrand Boulevard and running thence S. 60-43 E. 196.7 feet to an iron pin; thence S. 32-42 W. 71 feet to an iron pin; thence N. 61-56 W. 193.5 feet to an iron pin on the Eastern side of Scarlett Street; thence along the Eastern side of said street, N. 29-52 E. 75 feet to an iron pin, the point of beginning.
