RAINES AND FRANCES G. RAINES, their heirs and assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 72, Section I of Lake Forest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of Fairfield Drive, joint front corner Lots 71 and 72, and running thence N. 31-40 E. 207.3 feet to an iron pin, joint rear corner Lots 71 and 72; thence S. 61-45 E. 92.3 feet to an iron pin, joint rear corner Lots 60, 61, 72 and 73; thence S. 27-04 W. 220 feet to an iron pin on the Northeasterly side of Fairfield Drive, joint front corner Lots 72 and 73; thence along the Northeasterly side of Fairfield Drive N. 56-06 W. 110 feet to an iron pin, the point of beginning.
