All our right, title and interest if any we have in and to a tract of land located in Grove Township, County and State aforesaid, containing 18.02 acres according to survey and plat made by John C. Smith and J. Coke Smith, Registered Land Surveyors, in January 1952. It is designated on that plat as tract number 2 and begins at a point on creek or branch at corner of W. E. Campbell's land and runs thence S. 26 E. 18.00 to corner; thence N. 67 W. 21.08 to iron pin at joint corner of tracts numbers 1 and 2 on the Smith plat; thence along the joint line of those two tracts N. 17-45 E. 13.20 to iron pin in or near road at corner of tract number 3; thence S. 42-45 E. 4.50 to corner in branch or creek; thence down the meanderings of the said branch or creek 6.90 feet to the beginning corner;
