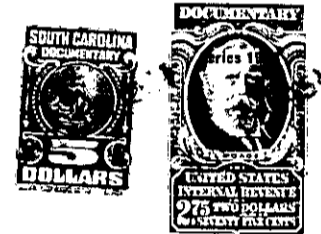

All that certain piece, parcel or lot of land situate, lying and being in ... view Township, Greenville County, South Carolina, and being a portion of tract No. 4 of the estate of L. F. Griffin, deceased, and having the following ... and bounds, to-wit:
