

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Furman University an eleemosynary corporation, its successors and assigns, forever:

All that lot of land, situate on the Northwest side of Duncan Chapell Road, and on the Northeast side of South Carolina Hi hway No, 88 (sometimes referred to as Roe-Ford Road) in Paris Mountain Township, Greenville County, S.C., and having, according to a survey made by Piedmont Engineering Service, August 16, 1954, the following metes and bounds to-wit:

BEGINNING at a point in the center of the Duncan Chapell Road and in the Northeast edge of South Carolina Highway No. 88 and running thence along the Northeast side of said highway N. 61-30 W. 200 feet to an iron pin; thence continuing along said highway N. 63-05 W. 100 feet to an iron pin; thence still along the Northeast side of South Carolina Highway No. 88 N. 67-14 W. 130 feet to an iron pin; thence N. 32-44 E. 167.2 feet to an iron pin; thence S. 66-48 E. 130 feet to an iron pin; thence S. 62-49 E. 100 feet to an iron pin; thence S. 32-44 W. 77 feet to an iron pin; thence S. 62-0 E. 200 feet to a point in the center of the Duncan Chapell Road; thence along the center of said Duncan Chapell Road S. 32-44 W. 90 feet to the beginning corner.
