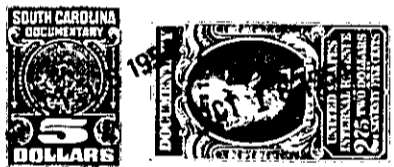
GRACE C. GARRISON, her heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 130, Section III, Lake Forest Subdivision, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 77, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Hermitage Road, joint front corner Lots 130 and 131, and running thence S. 45-07 W. 200 feet to an iron pin, joint rear corner Lots 130 and 131; thence N. 44-53 W. 137.1 feet to an iron pin in the center of a Duke Power Company Right-of-Way being the joint rear corner Lots 129 and 130; thence through the center of said Right-of-Way N. 40-03 E. 194.9 feet to an iron pin on the Southwesterly side of Hermitage Road, joint front corner Lots 129 and 130; thence along the Southwesterly side of Hermitage Road S. 51-35 E. 34 feet to a point; thence continuing along the Southwesterly side of Hermitage Road S. 45-04 E. 120.4 feet to an iron pin, the point of beginning.
