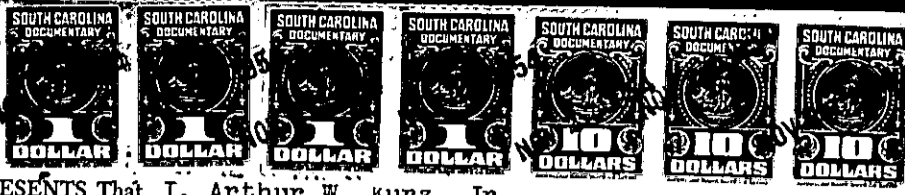

KNOW ALL MEN BY THESE PRESENTS That I, Arthur W. Kurz, Jr.,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

DOUGLAS T. NOAKES

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 119 of a subdivision known as Vista Hills, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book P at page 149, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Eastern side of Chick Springs Road at the joint front corner of Lots 118 and 119, said point being 147.5 feet North of the Northeastern intersection of Wellington Avenue and Chick Springs Road, and running thence S. 74-28 E. 172.3 feet to a point in the center of a 15-foot alley; thence with the center line of said alley N. 18-32 E. 83.7 feet to a point; thence N. 75-42 W. 176 feet to a point on the Eastern side of Chick Springs Road at the joint front corner of Lots 119 and 120; thence with the Eastern side of Chick Springs Road S. 15-40 W. 80 feet to the point of beginning.

The above description includes one-half of a 15-foot alley at the rear of this lot, but it is distinctly understood and agreed that the rear seven and one-half feet of this lot, together with the rear seven and one-half feet of the lots adjoining it in the rear, shall be used as a public alley, as shown on said plat for Vista Hills.

This deed is executed subject to existing and recorded restrictions and rights of way.

This is the identical property conveyed to the grantor herein by M. G. Proffit by his deed dated November 8, 1952, and recorded in the R. M. C. Office for Greenville County in Deed Book 466 at page 300.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

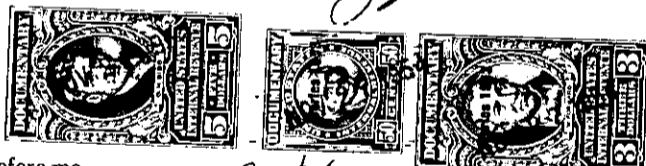
