E. Kennedy, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the Western side of Burgundy Drive, being known and designated as Lot No. 9, as shown on a plat of Wildair Estates, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book EE at Page 19, and being more particularly described as follows:

"BEGINNING at an iron pin on the Western side of Burgundy Drive at the joint front corner of lots Nos. 9 and 10, and running thence with the line of lot No. 10, S. 76-20 W. 192.5 feet to an iron pin in the line of property of Ruth G.
