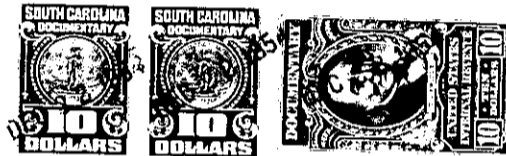

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southwesterly side of Westbrook Lane, near the City of Greenville, S. C., being shown as Lot No. 11, Block C, on the plat of Brookforest as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 41, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Westbrook Lane at a point 595.5 feet Northwest of the Westerly corner of the intersection of Westbrook Lane and Woodmont Circle, said pin being the joint front corner of Lots Nos. 10 and 11, Block C, and running thence along the joint line of said lots S 55-42 W 175 feet to an iron pin, corner of Lot No. 21: thence along the line with Lot No. 21 N 34-18 W 70 feet to an iron pin, joint rear corner of Lots Nos. 11 and 12: thence along the joint line of Lots Nos. 11 and 12 N 55-42 E 175 feet to an iron pin on the Southwesterly side of Westbrook Lane; thence along the Southwesterly side of Westbrook Lane S 34-18 E 70 feet to the point of beginning.

This is one of the lots conveyed to the grantor by the deed recorded in Deed Book 503, page 438.
