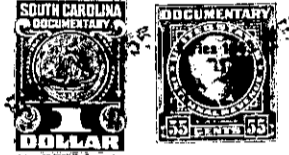

That I, Ray E. McAlister of the County of Greenville, in the State aforesaid,
in consideration of the sum of Three Hundred, Fifty (\$350.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert Edwards, his heirs, and assigns forever, all that piece, parcel, or lots of land in Greenville County, South Carolina, just North of Travelers Rest, South Carolina, being known, and designated as Lot No. 42 McAlister Street, as shown on a plat of Ray E. McAlister property, made by Pickell & Pickell, Engineers, dated October 16, 1948, and revised February 24, 1949, and recorded in the R. M. C. Office for Greenville County, South Carolina, and having according to said plat the following metes, and bounds, to-wit:

BEGINNING at an iron pin on McAlister Street, joint front corner of Lots Nos. 42 and 43, and running with the common line of said two lots, S. 41-40 W. 247.7 feet to an iron pin in the line of Lot No. 34; thence N. 45-48 W. 64.6 feet to an iron pin, rear corner of lot No. 35; thence N. 51-16 W. 35.5 feet to an iron pin; thence N. 41-40 E. 246.8 feet to an iron pin on McAlister Street, joint front corner of Lots Nos. 41 and 42; thence with McAlister Street, S. 48-20 E. 100 feet to an iron pin, the point of beginning.
