All that piece, parcel, or lot of land situate, lying, and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 17 of a subdivision known as Greenfields, Section 3, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book GG at page 93, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Dolphin Street, joint front corner Lots Nos. 16 and 17, and running thence with the joint lines of said lots, N. 82-45 E. 142.2 feet to an iron pin; thence S. 6-52 E. 80 feet to an iron pin, joint rear corner Lots Nos. 17 and 18; thence with the joint lines of said lots, S. 82-45 W. 141.6 feet to an iron pin on the eastern side of Dolphin Street; thence with said Street, N. 7-15 W. 80 feet to the point of beginning.
