Powers to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Carroll B. Powers and Betty J. Powers and their heirs and assigns forever:

All that certain parcel or lot of land situated on the west side of Woodland Drive, near the limits of the City of Greer and northward therefrom, in Chick Springs Township, Greenville County, State of South Carolina, being designated as Lot No. 16 of a subdivision known as "Pinebrook", according to survey and plat by H.S. Brockman, Registered Surveyor, dated February 21, 1955, and having the following courses and distances, to wit: Beginning at a stake on the west side of Woodland Drive, corner of Lots Nos. 15 and 16, and running thence along line of same, S. 79.30 W. 175 feet to a stake on bank of brook; thence up said brook as the line, S. 33.04 E. 125 feet to a stake, corner of Lot No. 17; thence along the line of Lot No. 17, N. 70.40 E. 134 feet to a stake on west side of Woodland Drive; thence along said Drive, N. 13.45 W. 95 feet to the beginning corner.

This property is conveyed subject to the Restrictions and Protective Covenants placed on this subdivision by the grantors herein of even date herewith, and to be recorded.

The grantees herein shall also have the right and privilege of crossing the brook for a connection to the main sewer line which is located on the grantors' property abutting the described lot on the west side, the said connection to be made at a point to be approved by the grantors herein or a majority of them.
