Know All Men by These Presents:

That I, G. Dewey Oxner, in consideration of the sum of ---Six Hundred Fifty and 00/100 (\$650.00)----- in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James D. Shives, his heirs and assigns:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Three(3) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the H.L.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following course and distances, to wit:

Beginning at an iron pin on Wheatley Place joint front corner of Lots 2 and 3 and running thence along the line of Lot No. 2 N. 73-37 W. 111.7 feet to an iron pin on line of Lot No. 12; thence along the line of Lot No. 12 S. 25-50 E. 30 feet to an iron pin corner of Lot No. 4; thence along the line of Lot No. 4 S. 58-21 W. 131.5 feet to an iron pin on Wheatley Place; thence along Wheatley Place N. 24-52 W. 70 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the H.L.C. Office for Greenville County in Deed Book 444, page 498, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said H.L.C. Office in Deed Book 445, page 235. It is understood and agreed that Lot No. Twenty-one (21) of Carver Park, or any part thereof, may be used for street purposes, so as to permit Gaston Street, now Elder Street, to be extended across Lot No. 21.

The lot herein conveyed constitutes a portion of the property conveyed to me by F. M. Caine, by deed dated March 19, 1951, and recorded in the H.L.C. Office for Greenville County in Deed Book 430, page 372.

All taxes for the current year to be paid by the grantor.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

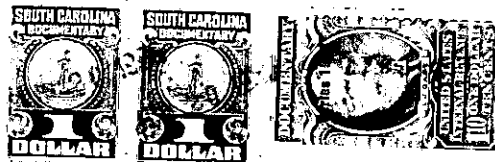
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
